

**Pennsylvania Pack**  
**Worthy Dog Robber Quarterly Report**  
**October 2008**

Dogs of Pennsylvania Pack,

I submit to you the following report for the 3rd quarter of 2008:

- We added 2 new Strays and 4 new DDs to the Pack at the Grand Growl held in June.
- I have received and sent our 2008-2009 installation report to Kennel on June 17, 2008.
- I received a new Pack roster from Kennel and sent copies of each Pound to the respective Dog Robber for verification. I received only 7 of them back. Those returned were from Pounds 38, 67, 169, 179, 213, 229 and 275. I would like to thank those Dog Robbers for their timely cooperation.
- I attended the 85th National Convention and 69th Supreme Growl.
- We had 3 new PDDs initiated at the Supreme Growl.
- I registered the Pack with the IRS and received our EIN number, which is 26-2924669.
- Received Installation Reports from the following Pounds; 22, 67, 132, 133, 169, 179, 188, 213 and 275.

I still have not received installation reports from Pounds 19, 20, 31, 38, 107, 109, and 229.

- Signed Pennsylvania Pack incorporation documents.
- September 1st starts the new fiscal year and dues are payable at that time. As per the last Kennel Roster, our Pack had 40 delinquent Dogs of which 6 have been reinstated so far. So, please make every effort to get these Dogs reinstated back into your Pounds.
- Since Grand Growl Pounds have initiated 3 new PUPs.
- Added 3 new Life members in the last quarter.
- For those Pounds that have not had elections and installation yet, please be aware that to be in compliance with Kennel Bylaws you must hold your elections and installations by November 13, 2008. The Bylaw is as follows:

**Section 205 - Growls - Regular, Annual, Special and Staff**

**A. REGULAR - Each Pound shall hold no less than four regular assemblies during any fiscal year, which assemblies shall include the annual assembly of the Pound, for the election of officers.**

**B. ANNUAL - Each Pound shall hold one annual assembly to be held during the three months following the month of the Supreme Growl of the Kennel. This assembly may be one of the regular assemblies specified in Paragraph A, above, and shall be designated a Growl of the Pound. At this annual Growl of the Pound the full order of business shall be called and acted upon, including the nomination, election and installation of Officers, and at which Growl the outgoing officers shall make full and proper reports and accounting to the Pound. The Installation Report for the new officers shall be submitted to the Honorable Kennel Dog Robber no later than the end of the month immediately following the Growl. The Installation Report shall be submitted via the Worthy Pack Dog Robber, if there is such, and a copy shall be sent to the respective Division Vice Chief Devil Dog.**
